**PUBLIC FORUM**

Mr Robinson of Home farm, Sturton attended the meeting and advised the parish councillors of the reasons why the planning application for the redundant farm buildings to residential dwellings at his farmstead has been submitted and asked the parish councillors to take these reasons into consideration when they consider the application next month.

Mr Reeve of the Scawby Brook residents association (ECO2) attended the meeting to encourage the parish council to provide the group with funding for legal advice. Mr Reeve also invited a parish councillor to join the residents association group.

3. **ADOPTION OF THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON WEDNESDAY 6<sup>th</sup> OCTOBER 2010.**

Cllr P Johnson proposed the minutes for adoption, seconded by Cllr T Barker and unanimously agreed.

4. **MATTERS ARISING FROM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 6<sup>th</sup> OCTOBER 2010.**

- i) Weight restriction for Scawby and lorry movements along Church Street– An email received from N.L.C advised the meeting that Brigg Haulage Company have agreed to direct all drivers to avoid driving through Scawby in the mornings when they are empty and instead will use the A15 and B1396. The lorries will drive through Scawby on their return journey because of the safety implications turning onto the A15 at Scawby Crossroads.

The request for a weight limit is noted and an officer will undertake a feasibility study of a weight limit and will let the parish council know the findings in due course.

The clerk thanked Cllr Poole for his help in resolving this matter.

- ii) Dog Fouling – email from N.L.C circulated who advise that they have erected two dog fouling/control order signs on Manor Drive and Old Manor Drive.

It was suggested that the leaflet provided by N.L.C should be displayed on the notice boards.

- iii) Fly Tipping – N.L.C report that there does not appear to be a problem with flytipping on Ermine Street – between April and October 2010 there have been 2 reported instances of flytipping in Scawby – Messingham Lane and Greetwell Cross Roads. It is therefore not possible to justify erecting warning signs or covert cameras. It was noted that there is some flytipping on the highway on Ermine Street, just off the A15 on the right hand side.
- iv) Property – St Hybalds. It was noted that The Chairman had requested that a letter not be sent to the resident of this property and Cllr Kitwood will try to ensure that this matter improves.
- v) Bulbs – Guides – Cllr Matthews purchasing the bulbs.
- vi) ECO2 Appeal – clerk advised that the appeal has been put back to March 1<sup>st</sup> 2011. The group fighting the appeal have approached the parish council for a donation towards their legal fees in this fight. The clerk asked the meeting to consider the advice provided by ERNLLCA regarding this matter(circulated) and **IT WAS RESOLVED** that the clerk would speak to ERNLLCA again regarding this matter – asking if parish councillors joined the residents group if this would alter the legality of providing financial help and Cllr England suggested that the parish council also took advice from Mike Wood – monitoring officer at N.L.C.
