PUBLIC FORUM

The Chairman welcomed Sarah Dauris to the meeting to inform the parish councillors and members of the public present about the ways in which ‘No Cold Calling’ zones can be introduced into villages.

Sarah Dauris advised the meeting that N.L.C promote ‘Trader Watch’ zones in conjunction with a Neighbourhood Watch Scheme – both of which require a co-ordinator who lives in the area where such ‘zones’ are required. Sarah Dauris advised the meeting that the ‘Trader Zones’ were not legally enforceable – but the posters etc do act as a deterrent to cold callers.

Sarah Dauris, along with Ken Bates the Neighbourhood Watch co-ordinator, agreed to visit Mr & Mrs Hill to discuss setting up a ‘Trader Watch’ and ‘Neighbourhood Watch’ scheme.

The Chairman thanked Sarah Dauris for attending the meeting and advising the meeting of the schemes available.

- iv) To give consideration and to set a budget for the purchase of a new litter bin to be situated on the grass verge near the layby/Post Office/Fish and Chip Shop. A list of bins available to purchase was circulated at the meeting and it was agreed to purchase a free standing bin with a capacity of 168litres – colour green with gold lettering. A budget of £600 was agreed to make this purchase.
- v) To give consideration to providing financial assistance to Scawby PCC towards the flood light repairs. The PCC accounts and financial statement was circulated at the meeting.
Cllr John Frost proposed a donation to the PCC of £500, seconded by Cllr T Barker. There were 8 votes recorded in favour of this proposal with 2 abstentions.
IT WAS RESOLVED to provide a donation of £500 to Scawby PCC.
- vi) To give consideration to entering the ‘Best Kept Village’ competition – **IT WAS RESOLVED** unanimously to enter the best kept village competition.
