**Welcome to Phil White – BWSC North Lincs Ltd.**

Update and question/answer session on Brigg Renewable Energy Plant.

**Members of the public are invited to participate in this discussion.**

Mr White provided the meeting with comprehensive information regarding the transport monitoring systems used by BWSC Ltd. Mr White advised the meeting that their main stack site was at Hemswell and a smaller storage site at the end of the M180 – both of these sites will use the designated route.

The concern regarding transporting of straw to the plant from LOCAL stacks was raised – in that they are exempt from using the designated route. Mr White advised that local straw stacks will be very minimal but in every case possible these will still be sent onto the designated route. If on the very rare occasion a local stack is genuinely exempt from using the designated route BWSC Ltd will try to relay this information – location, date and time and number of movements to the clerk who will advise councillors accordingly.

The Chairman thanked Mr White for attending the meeting and providing the information for the councillors.

**PUBLIC FORUM**

Three members of the public attended the meeting to advise the council that they felt the increase in HGV's travelling though the village was unacceptable. The Chairman advised the members of the public that this subject was an agenda item of this meeting and they were welcome to stay and listen to the parish councillors discussion on this matter.

## 11. NORTH LINCOLNSHIRE COUNCIL HIGHWAYS MATTERS

- i) To receive reports from Ridge Ward Councillors: No report to receive.
- ii) Traffic Monitoring – Messingham lane Scawby – to receive the monitoring information from Roy Hindmarsh – Information noted. Clerk to resend information to Cllr Barker.
- iii) To give consideration to the response written by Cllr Gibson – HGV's and weight limit in Scawby and agree progression of this matter.

North Lincolnshire Council were asked by Scawby parish council to consider implementing a weight limit in Scawby in 2013. This request was refused. The parish council along with residents believe that the volume of HGV traffic has increased considerably over the past two years. Cllr Platts advised the meeting that when the original request for a weight limit was refused in 2013 representatives from the parish council visit local hauliers and asked them, where possible, to avoid travelling through the village. This request was accepted by local hauliers and as far as possible have avoided travelling through the village.

**MOTION:** Proposed by Cllr Johnson, seconded by Cllr Barker – To write to N.L.C to insist that they reconsider implementing a weight limit in Scawby – taking into consideration the most recent traffic data available for Scawby. Ten votes in favour, 1 abstention – **MOTION CARRIED.**

- iv) Review of Action List – The action list was reviewed and certain items removed which have been progressed. Clerk to remind N.L.C about the Pinfold hedge.
- v) New Highways matters: Potholes/pavement repairs appear to have been marked for repair on Messingham lane/Manor drive corner but they have been missed. Clerk to follow up. There is an unsightly wire fence around the first cottage (renovated cottages, opposite village green) on church Street. Clerk to ask the estate if it can be removed. Cllr Mrs Powell advised the meeting that although Scawby village feels it is getting an unwarranted amount of HGV traffic through the village she had every sympathy for the residents of scawby brook who will suffer with the straw lorries attending the power station.

## 12. PLAYING FIELD AND VILLAGE MATTERS.

- i. Health and Safety Incidents at the playing fields and pavilion – To report that N.L.C have made repairs to the swings at their play area – in light of the playground inspection report.  
The bolts on the witches hat need tightening again – Cllr Frost to attend.
- ii. Pavilion – programme of improvement to the pavilion and surrounding area. Cllr Gibson advised the meeting that a firm had visited the pavilion, have been provided with a works list and will quote for all the works required individually. A competitive quote will also be sourced in due course.

- iii. Greetwell flower beds – report from Cllr R T Matthews reported that a site meeting had taken place with D Warburton and has managed to agree two flower beds at greetwell – top of Messingham Lane and one on Kirton Road. Clerk to chase up quote from D Warburton. Clerk to respond to resident of greetwell who had expressed disappointment that the flowers had been removed from the beds prematurely and not replaced for 3 weeks.

- iv. Winter salt – N.L.C will now top up all the green parish salt bins throughout the winter.

- v. Christmas lights switch on – Sunday 6<sup>th</sup> December – arrangements in hand.  
Cllr Frost has repaired some of the lights but a further set is required. The meeting agreed  
to the purchase of a further set of lights.  
Cllr Barker suggested N.L.C be asked to investigate the possibility of getting a permanent  
power supply to the village green – clerk to contact N.L.C to enquire how to go about achieving this.
- vi. New Village Matters: Cllr Mrs Chamberlain advised the meeting that comments had been placed on the agenda posted on the Messingham lane notice board complaining about the volume and speed of traffic through the village and dog fouling. Cars have been parking inappropriately on Martins road, partially blocking the road and on grass verges. It was agreed to monitor this problem and see if it resolves itself. Cllr Mrs Powell advised the meeting that there were can and broken bottles at the childrens play area recently and that there had been a wasps nest at the village hall which has now been treated.

The seat at Scawby Brook needs repair.

It was noted that the judge for the best kept front garden competition had been taken to lunch as a thank you for his time and help with the competition.
