a) Application PA/2017/1847 – Application for approval of reserved matters relating to the erection of a detached bungalow with planning provision (outline P.P granted 17/11/17 PA/2017/1350) – Land adjacent to 9 Gainsborough Lane, Scawby.

IT WAS RESOLVED that the clerk would complete the forms to allow on-line banking and provide information from ERNLLCA regarding parish councils financial regulations relating to on-line banking.
- iv) To give consideration to and set the precept for 2018/19.
 The budget for 2018/19 was discussed and agreed and **IT WAS RESOLVED** to set a precept of £37,000 for 2018/19. This has remained unchanged from last year.

i) New Police matters – There has been a house burglary and accident at Broughton xroads.

10. NORTH LINCOLNSHIRE COUNCIL HIGHWAYS MATTERS

i) To receive reports from Ridge Ward Councillors: No report to receive.

ii) Review of Action List: Open access to playing fields – Cllr Frost has had a meeting with a firm and a quote to supply and fit bollards will be supplied in due course.

Church Paddock nameplate signs – clerk to ask Mr Nelthopre if these are in hand.

iii) North Lincolnshire in Bloom initiative – Confirmation received that £1250 has been awarded.

Invoices required by mid February – Cllr Barker and clerk to try and arrange this.

iv) To receive the list of damaged footpaths which need repair to forward to N.L.C.

- End of Mill lane – near bus stop.
- Kirton Road Greetwell – towards the car garage
- West Street in the vicinity of the old shop and pub – both sides of the road.
- West Street – from Sturton Crossroads past the school to Coach House Gardens – both sides of the road.
- West Street – near the ONGO houses (service strip) area.

v) Snow warden – No further matters to report of this subject.

vi) New highways matters : 'Golden Rivers' on Messingham Lane have been removed – N.L.C will supply the parish council with the data in due course.

The West Street 'service strip' is an adopted highways road.

11. PLAYING FIELD AND VILLAGE MATTERS

i) Health and Safety incidents at the playing fields and pavilion: No matters to report.

ii) Playing Field/Football Pitches – The pitches will be managed until the end of the season.

iii) Village centre refurbishment – Budget provision for 2018/19 has been made to commence the village centre improvements.

iv) To give consideration to grassing over the small flower bed on West Street service strip.

IT WAS RESOLVED to keep this flower bed but to improve its profile by increasing it in size and possibly raising it to make more visible.

v) Tree planting scheme for Scawby – No update from Tim Allen received.

vi) Any new village matters: Clerk to ask Andy Sissons when he is box mowing at the flower bed on Lidgetts close to mow up to and around the seat.

Litter spilt by the dustbin collectors is still a problem particularly on Meadow Vale, Gainsborough lane and West Street. Clerk to report to N.L.C.

Fly tipping and litter is apparent from Broughton crossroads to the village – clerk to report to N.L.C. Litter is also a problem on Brigg Road to Mill lane, Scawby – clerk to report.

Cllr Keyworth asked the village hall representatives if the defibrillator at the village hall is serviced regularly. This is the responsibility of the ambulance service and it is maintained regularly.
